Upon paying the deposit and confirmed the reservation, Guests automatically accept the conditions in full, the regulation of the Campsite and the information contained inside the "AlboschettoSafety" file attached.

- Upon arrival, each Guests (including minor) is requested to hand over valid proof of identity for the legal registration procedure.
- The balance payment may be paid on the day preceding the departure day exclusively at the village counter during opening hours (8am-12pm/4pm-7pm). Cheques are not accepted.
- The age category of the pricelist is determined by the age of birth entered at check-in. Birthdays during stays do not allow rate changes.
- Departures of individual Guests during the stay must be paid at the time of actual departures and at the cash desk opening time.
- The Management will give each Guest a non-transferable bracelet, which must be worn on the wrist for the entire period of stay.
- Reservation must be made directly by the Guests who will be staying in the accommodation. They will only become binding once a deposit for an amount established by the Management has been paid and written confirmation has been sent. The reservation may not be transferred to a third party without the authorization of Camping Village Al Boschetto***.
- For organizational reasons, Management cannot guarantee the reservation of a specific number of lodging.
- The number of occupants cannot exceed the number of beds, the only exception is for a child until 12 months.
- Management guarantees lodging from 5 pm until 22 pm. Check-in is possible from 10 am and the Guests may wait inside of the Campsite for the availability of the unit, but not near it. Late arrivals must be reported to the Management.
